



# Slicker® Classic System Warranty

Benjamin Obdyke Incorporated – 400 Babylon, Suite A, Horsham, PA 19044

This TWO-PART LIMITED WARRANTY is made by Benjamin Obdyke Incorporated (BOI) to Professional Installers of Products purchased and identified herein, and to the Owners of residential buildings in which the Products are installed, subject to the following terms, conditions and definitions:

1. Definitions

“Professional Installer” means a Builder, or a General Contractor, or any other trades-person of ordinary skill in the installation of residential building products of the type purchased under this warranty.

2. “Owner” means either (a) an original purchaser of the residential building in which the Product is initially installed by a Professional Installer or (b) someone to whom the residential building is lawfully transferred during the Warranty Period.

3. “Warranty Period” means the length of the time measured from the date when the purchased Product is installed in the residential building in the U.S., or Canada, and a date either thirty (30), or thirty-five (35), fiscal years therefrom, as determined by Part A, or B, herein.

This **Limited Warranty** is effective for Benjamin Obdyke Products (“Products”) identified below and purchased and installed after **February 1st, 2023** in Canada and the United States.

## 30 YEAR PRODUCT ONLY LIMITED WARRANTY

Benjamin Obdyke Incorporated (“Benjamin Obdyke”) warrants that Slicker® Classic Rainscreen (6mm and 10mm) when installed in accordance with Benjamin Obdyke’s published installation instructions, is free from manufacturing defects for thirty (30) years from the date of purchase. To obtain service under this thirty (30) year product warranty, you must promptly contact Benjamin Obdyke at [techsupport@obdyke.com](mailto:techsupport@obdyke.com) or call 1-800-523-5261 regarding any potential claim, no later than thirty (30) days after you discover any potential claim, and you **MUST** provide Benjamin Obdyke with proof of purchase and/or of installation of the Products within the applicable warranty period. You must provide Benjamin Obdyke with a reasonable opportunity to inspect the building within sixty (60) days after Benjamin Obdyke receives notice of your potential claim. You must also provide access to Benjamin Obdyke to recover samples of the Products from the actual installation in sufficient quantities in order to perform testing to determine whether or not the Product failed due to causes as set forth herein.

If the Product(s) contains a defect covered by this warranty, Benjamin Obdyke, at its sole discretion, will either, (a) pay for the cost of materials to repair or replace the Slicker® Classic (6mm and 10mm), (b) provide a replacement rainscreen product of equal quality or value as a substitute, or (c) refund the original purchase price of the Slicker® Classic (6mm and 10mm). **In no event shall Benjamin Obdyke be obligated to pay for the cost of labor for such repair or replacement.**

## 35 YEAR PRODUCT AND LABOR LIMITED WARRANTY

Subject to the following Product specific terms and conditions, Benjamin Obdyke warrants that for a period of thirty-five (35) years from the date of purchase, Slicker® Classic (6mm and 10mm), FlatWrap® HP, HydroFlash®, HydroTape®, and HydroCorner™ products when installed in strict accordance with the applicable Benjamin Obdyke Installation instructions, in a properly constructed and designed wall system, following the applicable building codes and accepted industry standards for each type of structure, will:

for Benjamin Obdyke Slicker® Classic Rainscreen (6mm and 10mm):

- On structures five (5) stories or greater and any **Multi-Family, Mixed Use and Light Commercial projects** you **MUST** use the Project Registration process prior to installation to qualify under the Product and Labor Warranty. For Project Registration details, please see [www.benjaminobdyke.com](http://www.benjaminobdyke.com) or call 1-800-523-5261 **BEFORE** you commence installation.

When all conditions under this Product and Labor Warranty are met, if damage to the building is caused solely by the failure of any Product to meet the drainage, water and air holdout specification in the applicable Physical Property specification sheet, then Benjamin Obdyke will provide **replacement Product for all defective Product and pay all reasonable construction repair costs to correct any problem that arises solely out of the failure of the Benjamin Obdyke Products to conform to its published characteristics.** Benjamin Obdyke will not have any

liability under this warranty for the repair or cost of repair for more than the actual area of damage not to exceed \$20,000 per dwelling.

#### **PRODUCTS COVERED AND PRODUCT SPECIFIC CONDITIONS:**

Benjamin Obdyke Slicker® Classic Rainscreen (6mm and 10mm), FlatWrap® HP, HydroFlash®, HydroTape®DS, HydroCorner™, and Batten UV:

- **FlatWrap HP WRB** must be used as the primary WRB component in the rainscreen wall system.
- **HydroFlash Flashing** must be used along with applicable accessories as listed on Benjamin Obdyke Approved Products list.
- **HydroCorners are optional** and can be used to treat sills, but must be used along with **HydroFlash** per installation instructions.
- **Batten UV is optional** and can be used as a starter strip or perimeter vent
- Taping/sealing of housewrap seams is not required, but **HydroFlash or HydroTape DS** *must be used* if seams are taped or sealed.
- Substitution of any other products or installation methods not approved in writing prior to installation will void this Product and Labor Warranty.
- If secondary “sacrificial” layer is required for masonry/stone veneer/stucco applications, any product that meets minimum building code requirements can be used.

**Subject to the foregoing conditions and providing all applicable Benjamin Obdyke Products are used exclusively (no substitution of alternate product unless approved in writing), the Product and Labor Warranty will apply except as noted. This warranty will not cover any non approved / non compatible products or damages arising therefrom. #### **What is not covered?**

1. The gross negligence, or willful misconduct of the Builder, General Contractor or Professional Installer or of any third party, including the building owner.
2. Acts of God, including but not limited to, fire and lightning, hurricane, high winds.
3. Vandalism or harm caused by another.
4. Defects in the structure or a component of the structure (e.g., window, door, or wall system), contamination from building site chemicals, or premature deterioration of the building materials, or nonstandard use or application of the Products.
5. Foreign objects or agents, including the use of materials incompatible with Benjamin Obdyke materials.
6. UV exposure of the Products in excess of that set forth in the Physical Properties specification sheet.
7. Improper installation of the Products, improper building practices or design not in accordance with the applicable building code or industry standards, or any deviation from approved construction plans or project specifications, or failure to follow the applicable Benjamin Obdyke Installation Guidelines.
